# Interstate Limited Warranty

Interstate Battery System of America, Inc. (IBSA), an independent company from AAA, warrants to the original Purchaser that: 1) this battery is free of defects in material and workmanship for seventy-two (72) months following the original purchase date, and 2) prior to installation or use, the state of charge of this battery has been maintained at a level equal to or greater than the minimum level considered necessary under industry standards for batteries to perform effectively upon their use or installation. The foregoing warranty is non-transferable and intended solely for the benefit of the original Purchaser for use in the original vehicle of installation. The foregoing warranty is void if this battery is reinstalled in another vehicle.

In the event this battery is determined defective during the first thirty-six (36) months after the original purchase date, IBSA shall provide a free replacement of similar size and quality to the original Purchaser. For defects occurring between thirty-six (36) months and seventy-two (72) months after the original purchase date, the original Purchaser may obtain a replacement battery of similar size and quality upon payment of the then-current AAA Member price less a rebate in the amount of the then-current AAA Member price of the warranted battery multiplied by a fraction the numerator of which is the number of months remaining in the seventy-two (72) month warranty period and the denominator of which is seventy-two (72). The original purchase date shall be determined by reference to the original purchase invoice or a copy thereof. If the original purchase invoice is not available, the original purchase date shall be determined by reference to the date stamp on the battery. No cash refunds. Battery prices may vary by region and are subject to change at any time without notice. The then-current AAA Member battery price charged in connection with the foregoing warranty shall reflect existing prices applicable to the location of the purchase of the replacement battery.

IBSA is not responsible for batteries that fail due to (i) improper charging or maintenance, (ii) broken container or cover, (iii) damage caused by fire, excessive heat, wreckage, explosion, or freezing, (iv) damage caused by negligence, misuse, abuse, or neglect, (v) use in a non-automotive application or use inconsistent with the battery's intended application, or (vi) the use of special additives introduced to the battery.

IBSA IS NOT LIABLE FOR CONSEQUENTIAL, INCIDENTAL, OR INDIRECT DAMAGES, WHETHER BASED UPON TORT OR CONTRACT OBLIGATION.
